



## Extemporaneous Opening Statement

Revised 07/2017

**Purpose:** To experience the courtroom aspect of criminal law and to develop extemporaneous presentation skills.

**Description of Event:** Each member is led to a preparation room where, they are given a short description of a criminal incident and the charge. All students will prepare an opening statement for the prosecution. They will have 45 minutes to prepare. They will then enter the “courtroom” and present their statement in front of a judge.

**Limit:** 3 students per chapter

**Dress Code:** Appropriate dress to include; business attire, chapter uniform or other attire appropriate for the competition, or as directed by your chapter advisor.

### Rules and Procedures:

1. To be eligible for the competition a student must be enrolled in a secondary public service education program or a program completer as recognized by Florida Department of Education.
2. This is not a team event
3. Each student will be given a short description of an event
4. Students may not leave the preparation room
5. Students will have 45 minutes to prepare
6. Time limit for opening statement is 5 minutes
7. One-minute warning will be given
8. The judge will have the final decision for tie breakers
9. Competitors will be judged on style, demeanor, legal accuracy, and effectiveness (see judge’s scoring guidelines)
10. Competitors may bring only a writing implement, paper, and note cards

1. One-time keeper
2. A judge
3. Two courtesy corps members
